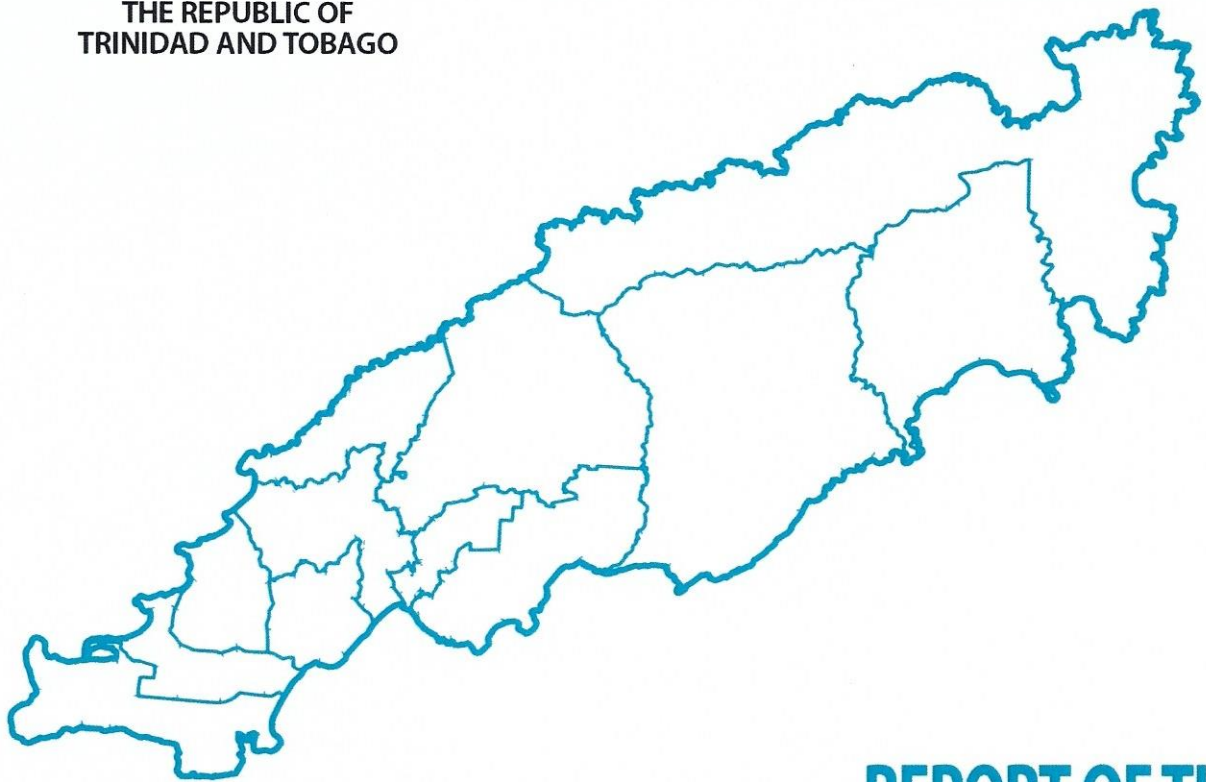

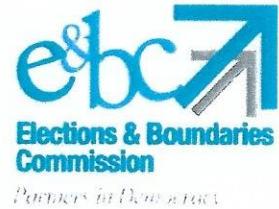

Election Rule 108(6) of the Representation of the People Act, Chapter 2:01 (the Act) requires the Elections and Boundaries Commission (the Commission) to cause to be printed, after each election, a report giving:

- (a) the number of votes polled for each candidate by polling divisions;
- (b) the number of rejected ballots;
- (c) the number of names on the revised list of electors and on the list of special electors; and
- (d) any other information that it may deem fit to include.

Further, the said rule specifies that a copy of the report shall be forwarded to the Minister responsible for local government, as well as to the Chief Administrator of the Tobago House of Assembly.

Acting in accordance with the said election rule 108(6), therefore, the Commission submits herewith its report on the Tobago House of Assembly Elections held on Monday 25th January, 2021. The data in respect of (a) and (b) above are provided in **Appendix I**. A summary of the information contained in **Appendix I** is given in **Appendix II**, while the requirement at (c) is met in **Appendix III**. Other pertinent information deemed fit for inclusion in the report, in addition to what is contained in this text, can be found in **Appendices IV-X** inclusive.

1. ANNOUNCEMENT OF THE DATE OF THE ELECTION

The Chairman of the Commission, Mr. Mark Ramkerrysingh was informed of the date of the election being Monday 25th January, 2021, via correspondence dated Tuesday 8th December, 2021 from Her Excellency, the President of the Republic of Trinidad and Tobago. The correspondence also indicated that Nomination Day had been fixed for Monday 4th January, 2021.

2. ISSUANCE OF WRITS OF ELECTION TO RETURNING OFFICERS

On Friday 11th December, 2020, the Chairman of the Commission delivered Writs of Election issued by Her Excellency, the President to the four (4) Returning Officers appointed by the Commission to conduct the poll in the twelve (12) electoral districts. This activity was held at the Shaw Park Complex, Shaw Park, Tobago.

In his address to the newly appointed Returning Officers, the Chairman thanked them for accepting the appointments and stressed the significance of their roles in the democratic process.

Returning Officers were assisted in the execution of their duties by four (4) Election Clerks appointed for this purpose by the Commission, as is provided for in Section 7 of the Act.

3. ELECTORAL REGISTRATION AND REVISED LIST OF ELECTORS

In accordance with the provisions of Section 30 of the Act, a nine-day period of electoral registration was conducted from 17th to 27th December, 2020.

While the time-span cited actually amounts to eleven (11) calendar days, the legal stipulation of nine (9) days was not exceeded. This is due to the fact that Christmas Day and Boxing Day (i.e. Friday 25th December, 2020 and Saturday 26th December, 2020), which fell within the period, had to be excluded in accordance with section 159(1) of the Act.

During the period of the Electoral Registration, a total of two (2) new registrations were effected, while forty-five (45) notifications of change of address were received.

The Preliminary List of Electors posted, as required, on the date of the commencement of the period of the Electoral Registration, reflected an electorate of fifty-one thousand and forty-three (51,043). Changes made to this list on the completion of the exercise, by way of additions and deletions, resulted in an electorate of fifty-one thousand and sixty-two (51,062) on the Revised List of Electors which was posted on 4th January, 2021. There were no adjustments to the Revised List; therefore a Supplemental List was not required.

4. NOMINATION DAY PROCEEDINGS

On Nomination Day, 4th January, 2021, twenty-six (26) candidates were nominated by four (4) political parties, while there were two (2) independent candidates. A total of twenty-eight (28) persons were, therefore, nominated to contest the election. Pertinent information relating to the candidates nominated is provided in **Appendix IX**.

The breakdown of the candidates nominated is provided in **Table 1** below, together with approved symbols.

5. POLLING STATIONS AND STAFFING

One hundred and one (101) polling stations were established for the purpose of the taking of the poll in the sixty-seven (67) polling divisions which constituted the twelve (12) electoral districts.

A total of seven hundred and ten (710) individuals received training in polling station and related poll day activities. Of this number, six hundred and sixty-three (663), comprising five hundred and sixty-eight (568) females and ninety-five (95) males, were assigned to work on poll-day. They were recruited to fill the positions of Presiding Officer, Deputy Presiding

Officer, Poll Clerk, Officer-in-Charge of the Ballot Box, Information Officer, Roving Officer and Sanitization Clerk.

6. COMMUNICATION

In addition to the usual pre-election advertisements, the Commission produced television and radio advertisements aimed at addressing any concerns which the voting public may have had about the electoral process during the COVID-19 pandemic. These advertisements provided information on the measures implemented by the Commission aimed at preventing the spread of COVID-19, and to safeguard the health and well-being of voters on poll-day.

7. PREPARATION FOR THE POLL/IMPACT OF THE COVID-19 VIRUS ON ELECTION PROCESSES

As it did in the preparation for, and conduct of the 2020 Parliamentary Elections, the first election to be held during the pandemic, the Commission again strictly followed the protocols set out by the Ministry of Health. Consequently, changes were made, but not restricted to:

- ❖ the training programme for prospective poll-day staff;
- ❖ the layout of polling stations; and
- ❖ the means by which election-related documents were made available to the public and election officials.

In all of this, the use of technology proved to be an effective tool.

Further, strict adherence was observed with respect to physical distancing, the mandatory wearing of masks, the wearing of gloves where deemed necessary, the sanitization of the hands of both voters and polling station personnel and the frequent sanitization of equipment provided for use at polling stations.

8. CONDUCT OF THE POLL

Voting by Special Electors commenced as scheduled, on Monday 18th January, 2021 at the offices of the respective Returning Officers, while similar activity began on Tuesday 19th January, 2021 at the Special Polling Stations established by the Commission for that purpose. All persons who turned up to vote were able to exercise their franchise without incident.

On poll-day, Monday 25th January, 2021, voting commenced as scheduled and there were no major incidents which negatively impacted the voting process. Election Day went as anticipated and all persons wishing to exercise their franchise were able to do so in the stipulated time.

As is customary, members of the Commission were deployed across the island on Election Day in order to monitor operations at polling stations. The casting of ballots and the counting of votes were incident free. Generally, the Commission was satisfied that poll-day arrangements enabled the electorate to exercise their franchise freely and fairly.

9. CHALLENGES TO PRELIMINARY RESULTS

Following the declaration of the preliminary results of the poll by Returning Officers, candidates or their Election Agents filed requests for a recount of the votes cast in four (4) electoral districts. This mandatory exercise, details of which are provided below, was conducted between Tuesday 26th January, 2021 and Wednesday 27th January, 2021.

9.1. Electoral District of Bethel/Mt. Irvine

The P.N.M. candidate, Mr. Shomari Ajani Hector, requested a general final count of votes and poll cards. The process commenced on Tuesday 26th January, 2021 at 3:00 p.m., and was concluded at 7:00 p.m. on the same day when the representatives of the P.N.M. candidate, with the consent of Mr. Hector, conceded defeat.

The P.N.M. candidate received two (2) additional votes in polling station number 4865, but lost two (2) votes in polling station number 4870, leaving the total overall votes received for the electoral district unchanged.

The recount did not alter the results of the preliminary count, and Mr. Terance Learie Baynes, the candidate for the P.D.P., was declared the winner.

9.2. Electoral District of Canaan/Bon Accord

The P.D.P. candidate, Mr. Joel Marcus Sampson, requested a general final count of votes and poll cards. The process commenced on Wednesday 27th January, 2021 at 10:07 a.m. and was concluded at 1:45 p.m. on the same day when Mr. Sampson, conceded defeat. The P.N.M. candidate, Mr. Clarence Roy Jacob received one (1) additional vote.

The recount did not alter the results of the preliminary count, and Mr. Clarence Roy Jacob, the candidate for the P.N.M., was declared the winner.

9.3. Electoral District of Lambeau/Signal Hill

The P.D.P. candidate, Mr. Wane Clarke, requested a general final count of votes and poll cards. The process commenced at 3:00 p.m. on Tuesday 26th January, 2021, and was concluded at 7:45 p.m. on the same day when the representative for the P.D.P. candidate conceded defeat.

The recount did not alter the results of the preliminary count, and Ms. Tracy Davidson-Celestine, the candidate for the P.N.M., was declared the winner.

9.4 Electoral District of Scarborough/Calder Hall

The P.D.P. candidate, Mr. Trevor W. James, requested a general final count of votes. The process commenced at 11:00 a.m. on Wednesday 27th January, 2021, and was concluded at 11:45 a.m. on the same day when the P.D.P. candidate conceded defeat.

The recount did not alter the results of the preliminary count, and Ms. Marslyn Erica Melville-Jack, the candidate for the P.N.M., was declared the winner.

The recounts in the electoral districts of Canaan/Bon Accord and Scarborough/Calder Hall commenced on Wednesday 27th January, 2021 instead of Tuesday 26th January, 2021, as stated in the Notice of Election (Form No. 35), because the respective Returning Officers had already scheduled recounts for 3:00 p.m. on Tuesday 26th January, 2021 in the electoral districts of Bethel/Mt. Irvine and Lambeau/Signal Hill respectively. As such, these requests could only have been accommodated after the conclusion of the recounts scheduled for Tuesday 26th January, 2021.

10. ELECTION DOCUMENTS

All relevant election documents have been submitted to the Commission for storage and are being maintained in safe custody in accordance with the Act.

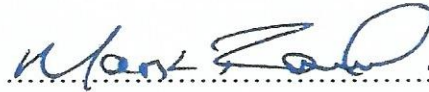
11. RESULTS OF THE POLL

The 2021 Tobago House of Assembly Election resulted in a deadlock between the People's National Movement and the Progressive Democratic Patriots; each party having won six (6) electoral districts.

The People's National Movement, however, obtained the popular vote with thirteen thousand, two hundred and eighty-nine (13,289) votes or 50.36% of the valid votes polled. The Progressive Democratic Patriots received a total of twelve thousand, seven hundred and ninety-eight (12,798) votes or 48.50% of the valid votes polled. The other two (2) political parties and two (2) independent candidates received a combined total of two hundred and ninety-nine (299) votes or 1.13% of the valid votes polled, as shown in **Appendix IV**.

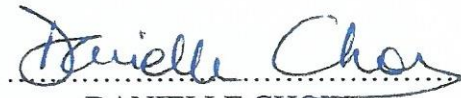
The number of electors exercising their right to vote amounted to twenty-six thousand, four hundred and seventy-four (26,474), representing 51.85% of the total number of eligible voters. The number of valid votes polled was twenty-six thousand, three hundred and eighty-six (26,386) or 99.67% and the number of ballots rejected was eighty-eight (88) or 0.33%.

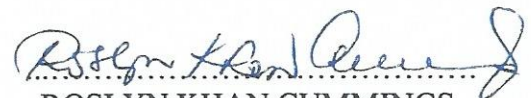
