E&BC Represented at International Conferences in Kenya

The Elections and **Boundaries** Commission led by its Chairman Dr. Norbert Masson and Senior Legal Officer, Mrs. Fern Narcis represented the Commission at the Third Biennial Conference of the Commonwealth Electoral Network (CEN) held in Nairobi, Kenya from, 23rd-24th June, 2014; and, the Eighth International Electoral Affairs Symposium organised the International Centre Parliamentary Studies (ICPS) Naivasha, Kenya from 25th-27th June, 2014.

The Third Biennial Conference of the Commonwealth Electoral Network (CEN) was facilitated by the Commonwealth Secretariat in association with the Independent Electoral and Boundaries Commission of Kenya. Its working theme was entitled 'Managing Elections in the 21st Century: Strengthening Institutional Capacity and Electoral Integrity'. The conference attracted senior election managers in the Commonwealth whilst offering important opportunities to promote various aspects of good electoral practice through peer learning and support.

In his opening remarks, Commonwealth Secretary-General Kamalesh Sharma said he was confident that the conference marked another milestone in the collective efforts to promote all aspects of good electoral practice through peer learning and support, thus enhancing the democratic culture and service to citizens. He added that links nurtured and strengthened through CEN are a powerful practical illustration of Commonwealth connection as a great global good.

The subsequent Symposium in Naivasha, Kenya from 25th – 27th June, 2014 was highly interactive as participants were able to exchange views, experiences and best practices in electoral management and administration. Additionally, they gained first hand insights about different approaches and rationales on managing various challenges, such as, low voter turnout, electoral legitimacy and voter registration. The Symposium also encouraged relationship building and networking with participants from Electoral Management Bodies, International Institutions and Technology Partners.

Chief Election Officer in ISO/TS 17582:2014 Training Workshop in Costa Rica

Chief Election Officer of the Elections and Boundaries Commission, Mr. Ramesh Nanan was in San Jose, Costa from 19-20 June, 2014 to attend a two (2) day training workshop for electoral organizations at all levels of the Government on the new International Electoral Standard ISO/TS 17582:2014: Quality Management Systems.

ISO/TS 17582:2014 specify requirements for a quality management system where an electoral organization:

- Demonstrates its ability to manage elections by secret ballot, which provide reliable, transparent, free and fair results that comply with electoral requirements;
- Within the established legal framework, aims to enhance the trust and confidence of citizens, candidates, political organizations, and other electoral interested parties through the effective implementation of the electoral quality management system, including processes for continual improvement.
- ISO/TS 17582:2014 applies to the election period, including pre-election and post-election activities or processes.
- 4. ISO/TS 17582:2014 is applicable to all electoral bodies involved in any aspect of the electoral process, whether they are permanent organizations or temporary organizations established in support of a particular election period and;
- It is also applicable to elections at all levels of Government, whether Local, Regional or Parliamentary.

The objective of the two-day workshop was to promote awareness of ISO/TS 17582 among the electoral community, to provide practical knowledge on how to implement the standard, and to provide a forum for understanding how to create a practical electoral quality management system. In the past, the Commission has always demonstrated a fervent interest in the development of International Standard for Electoral Bodies, so participation at this workshop would have been highly beneficial to both the Commission and its Department.

Deputy Chief Election Officer in CARICOM Observer Electoral Mission



The role of the mission as outlined by

CARICOM was as follows:

To Observe

- The Electoral Process
- Preparations for Polling Day
- Casting of Votes
- Closure of the Polling Station



Preparation for the Statement of the Poll

To Collect

- Information on the result of the voting tables to assist in the quantitative verification of the results.
- Qualitative observations regarding the voting process, comportment of the electoral officials and political actors and on the overall electoral environment.

VOTE

To Observe and Assess

• The outcome of the elections and the initial immediate impact on the social and political environment

Collaborate

• In the preparation of the report to be prepared by the Chief of Mission, through the submission of observation sheets, oral and written reports and findings on the day of election.

Integrity System Upgrade

During the period of 16th - 18th June, 2014, DeLaRue, the Security Company entrusted with the security of the National Identification Card, visited the Elections and Boundaries Commission (Commission) as part of its current service contract to upgrade the Commission's software. These services include upgrades to software for registration, boundaries and on Election Day.

The Registration upgrade will involve:

- **Production State Monitoring**, which displays and monitors the identification card at every state in production;
- **Self Service Registration**, via the Commission's website whereby a registration transaction can begin online;
- **Document Imaging Option**, where information on scanned documents can be retrieved such as birth certificates and transfer forms.

Additional upgrades have also been proposed to the boundaries Geographic Information System (GIS) Integration software, which is designed to pinpoint the exact location of a registrants' residence and display images of boundaries. Finally, upgrades to software to facilitate speedy tabulation and dissemination of election results and even results in real time.

All the service upgrades outlined above are still in the implementation phase but in the very near future, the Commission can look forward to a more efficient registration process, which will benefit registrants across the country.
