## ERRATA SHEET

Following the production of the Fourteenth Report of the Elections and Boundaries Commission on the Boundaries of the Electoral Districts in the Electoral Area of Tobago (the Report), an audit of the Tobago Polling Division (PD) subdivision exercise was conducted. This disclosed latent misregistrations resulting from unclear and/or inconsistent street naming within PDs forming part of the Electoral Districts of Mason Hall/Moriah, Bagatelle/Bacolet, Plymouth/Black Rock and Bethesda/Les Coteaux.

The Commission sought to further enhance the accuracy of electorate summaries through successive field investigations within impacted PDs to ascertain the residential location of electors as of the 7<sup>th</sup> July 2025 – to be consistent with electorate figures used throughout in the Report's analysis.

The field investigations identified misregistrations in the Electoral Districts of Mason Hall/Moriah and Bethesda/Les Coteaux, resulting in changes to electorate figures in these districts, and subsequently in Bagatelle/Bacolet and Plymouth/Black Rock through respective transfers.

These revisions do not necessitate changes to the recommendations made herein.




Figure 1: In reference to page VIII of the report




Figure 2: In reference to page IX of the report




Figure 3: In reference to page X of the report




Figure 4: In reference to page XII of the report




Figure 5: In reference to page XIV of the report
