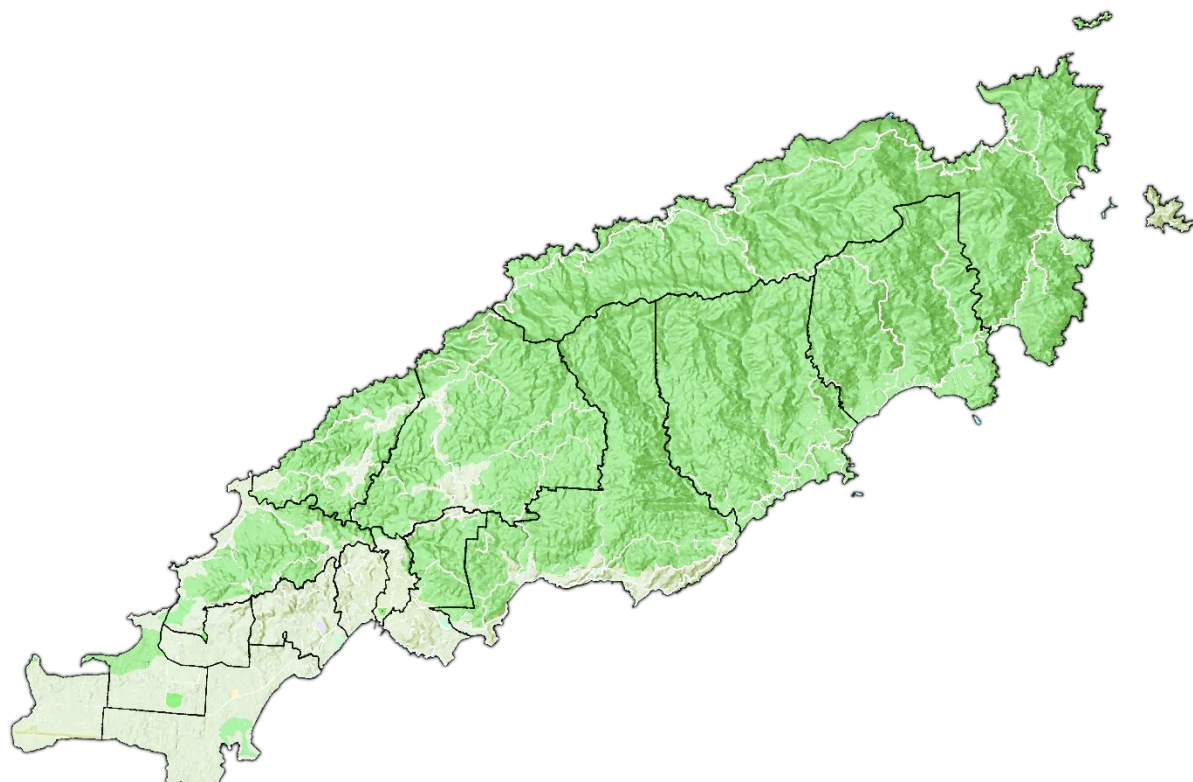

Report of the Elections and Boundaries Commission on the Tobago House of Assembly Elections held on Monday 6th December, 2021

1. INTRODUCTION

Election Rule 108(6) of the Representation of the People Act, Chapter 2:01 (the Act) requires the Elections and Boundaries Commission (the Commission) to cause to be printed, after each election, a report giving:

- (a) the number of votes polled for each candidate by polling divisions;
- (b) the number of rejected ballots;
- (c) the number of names on the revised list of electors and on the list of special electors;
and
- (d) any other information that it may deem fit to include.

Further, the said rule specifies that a copy of the report shall be forwarded to the Minister responsible for local government, as well as to the Chief Administrator of the Tobago House of Assembly.

Acting in accordance with the said election rule 108(6), therefore, the Commission submits herewith its report on the Tobago House of Assembly Elections held on Monday 6th December, 2021. The data in respect of (a) and (b) above are provided in **Appendix I**. A summary of the information contained in **Appendix I** is given in **Appendix II**, while the requirement at (c) is met in **Appendix III**. Other pertinent information deemed fit for inclusion in the report, in addition to what is contained in this text, can be found in **Appendices IV-X** inclusive.

2. BACKGROUND

The Tobago House of Assembly (THA) Election held on Monday 25th January, 2021 resulted in an electoral deadlock in the THA with the People's National Movement (P.N.M.) and the Progressive Democratic Patriots (P.D.P.) each having won six (6) of the twelve (12) seats. This was the first time that this issue had become relevant since the THA had been established in 1980.

The twelve (12) elected members were unable to successfully elect a Presiding Officer and as a consequence, the THA remained dissolved after the election with an interim Executive Council remaining in place to discharge its function in accordance with Section 34(4) of the Tobago House of Assembly Act, Chapter 25:03. This impasse led to a constitutional crisis which ultimately required the intervention of the Parliament of Trinidad and Tobago (the Parliament) to propose a solution.

2.1 THA Amendment Act 2021

To offer a solution to the impasse, the Parliament passed the Tobago House of Assembly (Amendment) Bill in the House of Representatives and the Senate on 19th February, 2021 and 2nd March, 2021 respectively. The Tobago House of Assembly (Amendment) Act, No. 2 of 2021 sought to amend the Tobago House of Assembly Act, Chap. 25:03 and to make consequential amendments to the Elections and Boundaries (Local Government and Tobago House of Assembly) Act, Chap. 25:50. This was assented to on 16th March, 2021 and subsequently proclaimed on 26th July, 2021 by Her Excellency, the President of the Republic of Trinidad and Tobago.

This legislation included a new provision for a procedure to be followed when no Assembly is formed after an election and in order to break the deadlock, section 4 of the Act amended section 5(1)(a) of the Tobago House of Assembly Act by increasing the number of Assemblymen that may be elected to the Assembly, from twelve (12) to fifteen (15).

Consequently, the Commission was required to submit a report on the Boundaries of the Electoral Districts in the Electoral Area of Tobago within ninety (90) days from the date of proclamation of this Act, changing the number of electoral districts in Tobago from twelve (12) to fifteen (15).

2.2 Thirteenth Report of the Elections and Boundaries Commission on the Boundaries of the Electoral Districts in the Electoral Area of Tobago

The Commission created three (3) additional districts in the electoral area of Tobago, pursuant to section 4(1) of the Elections and Boundaries Commission (Local Government and Tobago House of Assembly) Act as amended by the THA Amendment Act namely:

- Lambeau/Lowlands;
- Darrel Spring/Whim; and
- Mt. St. George/Goodwood

There were also name changes in other electoral districts to more accurately reflect geographical locations.

The move from twelve (12) to fifteen (15) districts was chronicled in the Thirteenth Report of the Elections and Boundaries Commission on the Boundaries of the Electoral Districts in the Electoral Area of Tobago. Based on this report, a Draft Order was laid before the Parliament on 10th September, 2021 and subsequently approved on 15th September, 2021 paving the way for fresh elections to be held in Tobago.

3. ANNOUNCEMENT OF THE DATE OF THE ELECTION

The Chairman of the Commission, Mr. Mark Ramkerrysingh was informed of the date of the election being **Monday 6th December, 2021**, via correspondence dated Wednesday 13th October, 2021 from Her Excellency, the President of the Republic of Trinidad and Tobago.

The correspondence also indicated that *Nomination Day* had been fixed for **Monday 15th November, 2021**.

4. ISSUANCE OF WRITS OF ELECTION TO RETURNING OFFICERS

On Sunday 17th October, 2021, the Chairman of the Commission delivered Writs of Election issued by Her Excellency, the President to the five (5) Returning Officers appointed by the Commission to conduct the poll in the fifteen (15) electoral districts. This activity was held at the Anne Mitchell-Gift Auditorium, Tobago Library Services, Scarborough, Tobago.

In his address to the newly appointed Returning Officers, the Chairman thanked them for accepting the appointments and stressed the significance of their roles in the democratic process.

Returning Officers were assisted in the execution of their duties by five (5) Election Clerks appointed for this purpose by the Commission, as is provided for in Section 7 of the Act.

5. ELECTORAL REGISTRATION AND REVISED LIST OF ELECTORS

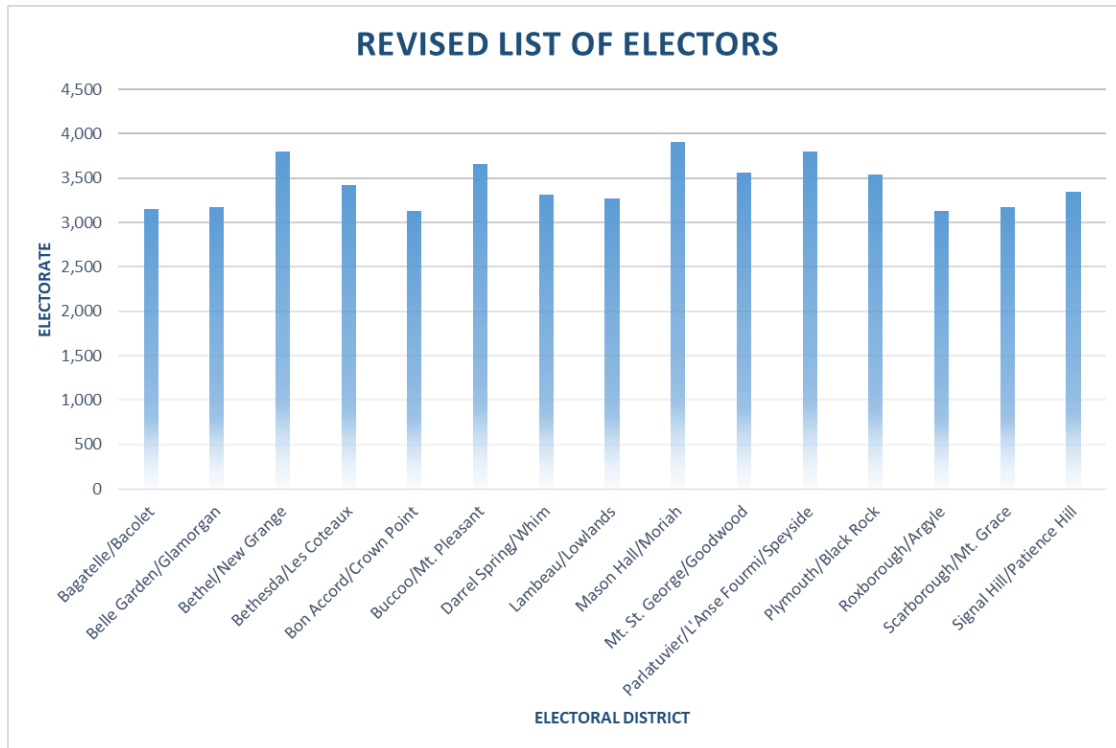
In accordance with the provisions of Section 30 of the Act, a nine-day period of Electoral Registration was conducted from 19th to 27th October, 2021.

During the period of Electoral Registration, a total of twenty-three (23) new registrations were effected, while eighty (80) notifications of change of address were received.

The Preliminary List of Electors posted, as required, on the date of the commencement of the period of Electoral Registration, reflected an electorate of fifty-one thousand, two hundred and twenty-seven (51,227).

Changes made to this list, by way of additions and deletions, resulted in an electorate of fifty-one thousand, three hundred and eighty-three (**51,383**) on the Revised List of Electors which was posted on 15th November, 2021 (see **Figure 1** below).

There were no adjustments to the Revised List; therefore a Supplemental List was not required.

6. NOMINATION DAY PROCEEDINGS

On Nomination Day, 15th November, 2021, forty-five (**45**) candidates were nominated to contest the election by five (**5**) political parties. There were no independent candidates contesting this election. Pertinent information relating to the candidates nominated is provided in **Appendix IX**.

The breakdown of the candidates nominated is provided in **Table 1** below, together with approved symbols.

7. POLLING STATIONS AND STAFFING

One hundred and one (**101**) polling stations were established for the purpose of the taking of the poll in the sixty-seven (**67**) polling divisions which constituted the fifteen (**15**) electoral districts.

A total of seven hundred and sixty-eight (**768**) individuals received training in polling station and related poll day activities. Of this number, six hundred and seventy-six (**676**), comprising five hundred and eighty (**580**) females and ninety-six (**96**) males, were assigned to work on poll day. They were recruited to fill the positions of Presiding Officer, Deputy Presiding Officer, Poll Clerk, Officer-in-Charge of the Ballot Box, Information Officer, Roving Officer and Sanitization Clerk.

8. COMMUNICATION

In accordance with legislation, pre-election advertisements were published in the local newspaper and the Gazette as required and they were also posted on the Commission's website.

In addition to the usual pre-election advertisements, the Commission produced television and radio advertisements to address any concerns which the voting public may have had about the electoral process during the COVID-19 pandemic. This included information on the measures implemented by the Commission aimed at preventing the spread of COVID-19, and to safeguard the health and well-being of voters on poll day.

9. USE OF TECHNOLOGY

Towards the improvement of election management procedures, the Commission formulated a pilot project for the generation of real-time data on voter turnout in two electoral districts which would guide the introduction of this initiative in all electoral districts in future elections. This proposed data collection initiative was not intended to replace the manual one on this occasion but to run in conjunction with the usual practice.

The Commission was unable to receive consensus on the introduction of the initiative for this election as some political parties needed more time to study the proposal and so decided to defer this project to a future election after there is an opportunity for further consultation with all stakeholders.

10. PREPARATION FOR THE POLL/IMPACT OF THE COVID-19 VIRUS ON ELECTION PROCESSES

As it did in the preparation for, and conduct of, previous elections held during the pandemic, the Commission again stringently followed the protocols set out by the Ministry of Health. Consequently, changes were made, but not restricted to:

- ❖ the training programme for prospective poll day staff;
- ❖ the layout of polling stations; and
- ❖ the means by which election-related documents were made available to the public and election officials.

In all of this, the use of technology proved to be an effective tool.

Additionally, all Returning Officers and their staff were requested to be fully vaccinated prior to being considered for employment with the Commission. The Commission also employed fully vaccinated persons as poll day staff as far as was practicable.

Further, strict adherence was observed with respect to physical distancing, the mandatory wearing of masks, the wearing of gloves, where deemed necessary, the sanitization of the

hands of both voters and polling station personnel, and the frequent sanitization of equipment provided for use at polling stations.

11. CONDUCT OF THE POLL

Voting by Special Electors commenced as scheduled, on Monday 29th November, 2021 at the offices of the respective Returning Officers, while similar activity began on Tuesday 30th November, 2021 at the Special Polling Stations established by the Commission for that purpose. All persons who presented themselves to vote were able to exercise their franchise without incident.

On poll day, Monday 6th December, 2021, voting commenced as scheduled and there were no major incidents which negatively impacted the voting process. Election Day went as anticipated and all persons wishing to exercise their franchise were able to do so in the stipulated time.

As is customary, members of the Commission and senior members of staff were deployed across the island on Election Day in order to monitor operations at polling stations. The casting of ballots and the counting of votes were incident free. Generally, the Commission was satisfied that poll day arrangements enabled the electorate to exercise their franchise freely and fairly.

12. CHALLENGES TO PRELIMINARY RESULTS

Following the declaration of the preliminary results of the poll by Returning Officers, candidates or their Election Agents filed requests for a recount of the votes cast in two (2) electoral districts. This mandatory exercise, details of which are provided below, was conducted on Tuesday 7th December, 2021.

12.1. Electoral District of Buccoo/Mt. Pleasant

The P.N.M. candidate, Mr. Ancil K. Dennis, requested a general final count of all poll cards and ballots cast in all polling divisions of the Electoral District of Buccoo/Mt. Pleasant. The process commenced on Tuesday 7th December, 2021 at 3:00 p.m. and was concluded at 1:37 a.m. on Wednesday 8th December, 2021.

As a result of the count, the P.N.M candidate lost one (1) vote while the P.D.P. candidate and the candidate for C.A.R.M. each received one (1) additional vote. There were no changes in the number of votes received by the other two (2) candidates. The recount did not alter the results of the preliminary count, and Mr. Sonny Craig, the candidate for the P.D.P., was declared the winner.

12.1.1. Request for a check of the results of the poll

Following the general final count in the Electoral District of Buccoo/Mt. Pleasant, the P.N.M. candidate, Mr. Ancil Dennis then requested a check of the results of the poll for this district. This activity was conducted on

Monday 13th December, 2021 at the Lambeau Multipurpose Facility. The exercise commenced at 10:02 a.m. and concluded at 11:37 a.m. on the same day.

At the conclusion of this exercise, both the P.N.M. candidate, Mr. Ancil K. Dennis and the P.D.P. candidate, Mr. Sonny Craig lost one (1) vote. The outcome of the check of the results of the poll therefore did not alter the results of the preliminary count, and the candidate for the P.D.P., Mr. Sonny Craig, was confirmed as the winner.

12.2. Electoral District of Darrel Spring/Whim

The P.D.P. candidate, Ms. Abby Tinica Taylor, requested a general final count of all votes cast and poll cards in the Electoral District of Darrel Spring/Whim. The process commenced on Tuesday 7th December, 2021 at 3:15 p.m. and was concluded at 10:50 p.m. on the same day when the representative for the P.D.P. candidate, conceded defeat. At the conclusion of the exercise, there were no changes to the number of votes received by either candidate.

The recount did not alter the results of the preliminary count, and Mr. Kelvon Morris, the candidate for the P.N.M., was declared the winner.

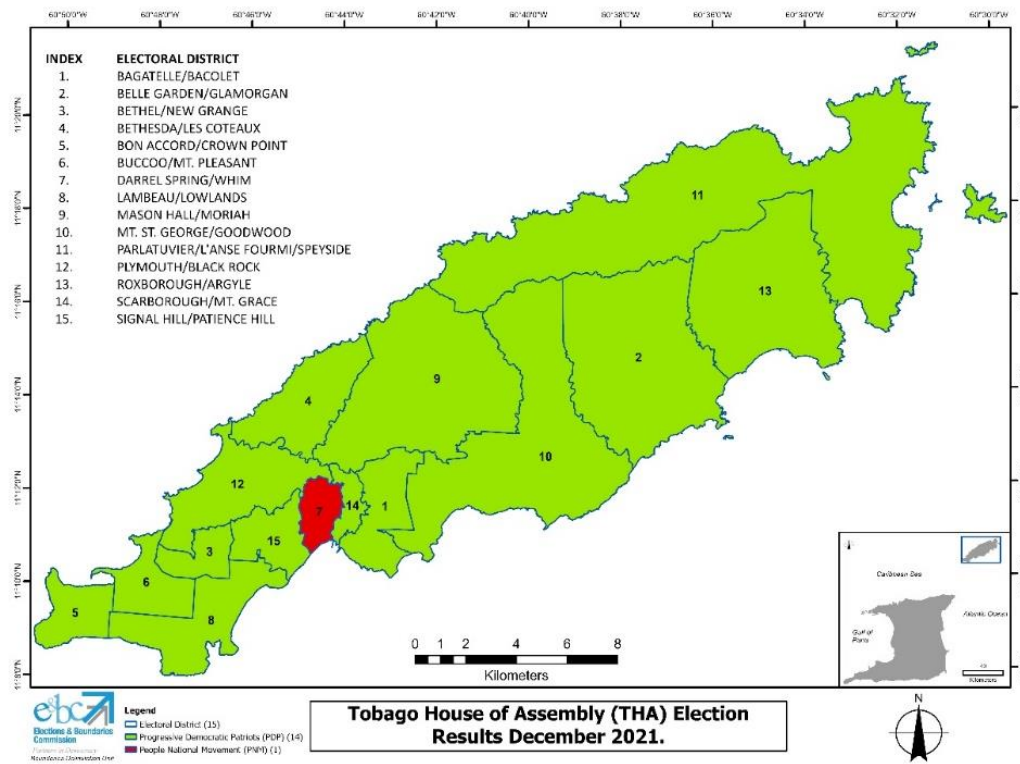
13. ELECTION DOCUMENTS

At the end of the voting and reporting election period, all relevant election documents have been submitted to the Commission for storage and are being maintained in safe custody in accordance with the Act.

14. RESULTS OF THE POLL

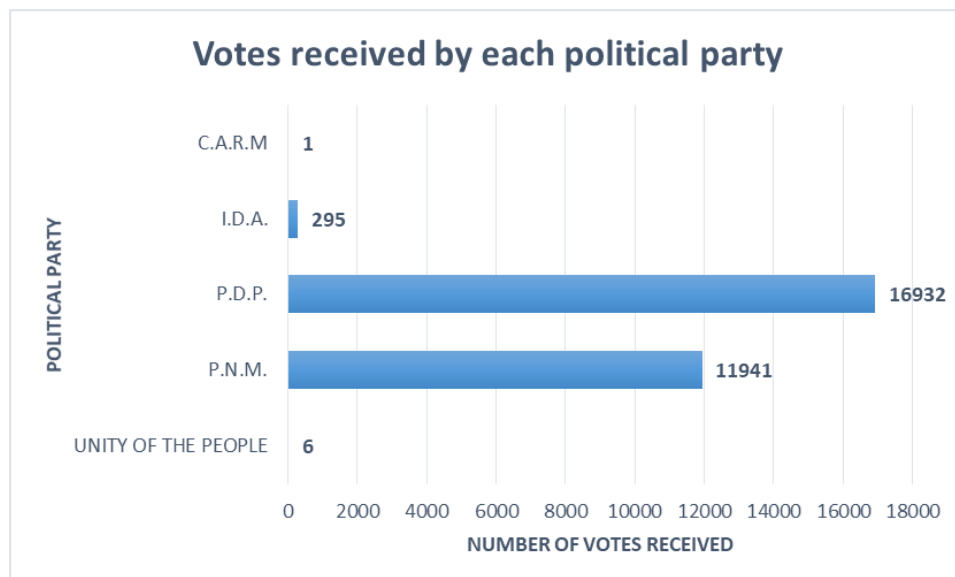
The December 2021 Tobago House of Assembly Election was won by the Progressive Democratic Patriots; their candidates having won fourteen (14) electoral districts. The People's National Movement won the Electoral District of Darrel Spring/Whim.

Figure 2: Map of Tobago showing the Results of the Poll



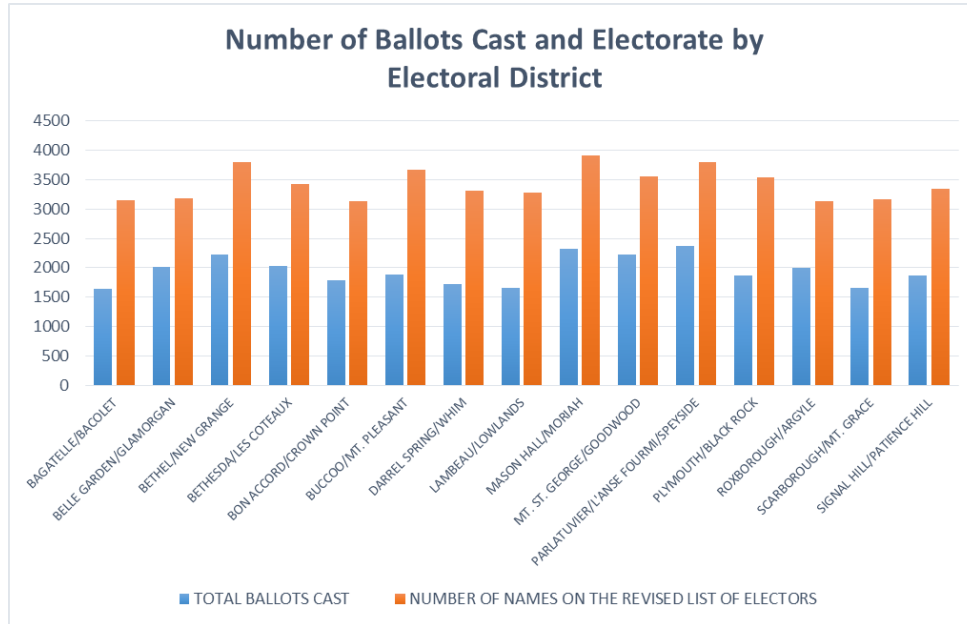
The Progressive Democratic Patriots obtained the most votes with sixteen thousand, nine hundred and thirty-two (**16,932**) votes or **58.04%** of the valid votes polled. The People's National Movement received a total of eleven thousand, nine hundred and forty-one (**11,941**) votes or **40.93%** of the valid votes polled. The other three (**3**) political parties received a combined total of three hundred and two (**302**) votes or **1.03%** of the valid votes polled, as shown in **Appendix IV** and **Figure 3** below.

Figure 3: Votes received by each political party



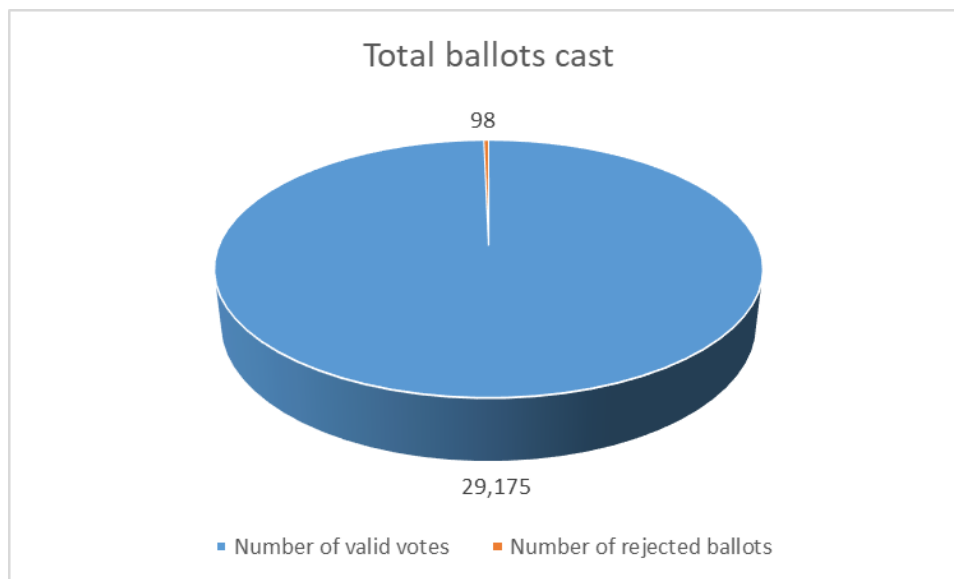
The number of electors exercising their right to vote amounted to twenty-nine thousand, two hundred and seventy-three (**29,273**), representing **56.97%** of the total number of eligible voters, as shown in **Figure 4** below.

Figure 4: Number of Ballots Cast and Electorate by Electoral District




Figure 5: Total ballots cast

The number of valid votes polled was twenty-nine thousand, one hundred and seventy-five (**29,175**) or **99.67%** and the number of ballots rejected was ninety-eight (**98**) or **0.33%**, as shown in **Figure 5** below.


